Council Meeting Minutes

CT Hornberger stated that TA Smart stated that we can go back to court and have the Town do the job, but it will cost more money for the Town to go back to court.

CP B. Russell stated that the Town Marshall requests more money on Salary, CT Hornberger stated that we cannot do a pay increase in the middle of the year, we can only do pay increases during budget time.

CT Hornberger wanted to remind everyone that the Auntie Annes Truck is coming to Moores Hill Veterans Memorial Park on June 30<sup>th</sup>, 2023.

LRSS Dell stated that he needs help doing things around Town and asked that we hire a seasonal helper to help during the summer. The council stated that the new hire can work 15-20 hours a month for 2 months and that they have to be 16 years old and older to apply for the position.

LRSS Dell stated that the homeowner at 14414 Wood Street is being split into 2 different properties. Mike Lawrence bought the property and intended on placing a factory on the property. Dell stated that we need to look into placing the property as Commercial instead of residential.

TM Monahan gave his monthly report to Ingersoll and Ingersoll read the report out loud.

WWTPO Grimsley wanted to thank TM Monahan for helping with the homeless man that was living in the hunting blind that sits next to 350 and is posted for sale.

Misty Russell stated that the Firehouse is having its yearly hog roast on Saturday Sept. 9<sup>th</sup>. Russell also stated that they are wanting to have a side by side or ATV ride to benefit the firehouse this year. Russell asked that the Town help with advertising for the event and place information about it on the monthly sewer bills.

Lynn Allen stated that Kim Hoffman had reached out and asked about using the Towns water slide for a church event. Council asked that she lets us know if they will be able to man it the whole time, they have it and if they have insurance to cover it and for her to sign an agreement to use it.

Raymond asked Bobby to reach out to Susan Craig with SIRPC and discuss the grant process.

Lynn Allen stated that when she went to the Sewer Regional District meeting, they stated that the Town needs to go to Dearborn County Commissioners about getting funds to run lines on 350. Allen stated that everyone needs to talk with each other and share information, that way we don't go to the County and look like fools.

Motion to have Tim Hunt with HWC Engineering be the Towns Engineer for use to run sewer lines down 350 CP B. Russell, 2<sup>nd</sup> CM Ingersoll; motion carried.
